

We work hard to adapt our provision to enable every child to take part both inside the classroom and in the wider school environment. 1. What types of SEN does the school provide for?

Our school provides for pupils with the following needs:

2. Which staff will support my child, and what training have they had?

The school is lucky to have a range of experienced staff. The school is also well supported by experienced teaching assistants. A variety of training has been provided over the past couple of years including external training, training from specialist teachers and in house training.

Our special educational needs co-ordinator, or SENDCO

Our SENDCO is Mrs Mayes .

She has a number of year of experience as a teacher. She was praised in the school's recent Ofsted and they noted that

"Pupils with special educational needs and/or disabilities (SEND) progress well through the curriculum. Adaptations to learning ensure that these pupils have full access to the curriculum."

She is a qualified teacher. She is part way through her National Award in Special Educational Needs Coordination. There is one day per week allocated towards SEND Coordination.

Class Teachers

All of our teachers receive in-house SEN training, and are supported by the SENCO to meet the needs of pupils who have SEN. This work has focused around adaption of learning over the past year.

Teaching Assistants (TAs)

We have a team of TAs who are trained to deliver SEN provision.

In the last academic year, TAs have been trained in a range of different interventions/



External agencies and experts

Sometimes we need extra help to offer our pupils the support they need. Whenever necessary we will work with external support services to meet the needs of our pupils with SEN and to support their families. These include:



3. What should I do if I think my child has SEN?

At St Augustine's we follow the Plymouth CAST SEND Pathway. This follows a graduated approach to SEND.

Identification of Special Educational Needs - Pathway



If you think your child might have SEN, the first person you should tell is your child's teacher.

You can do this by asking at the office.

They will pass the message on to our SENCO, who will be in touch to discuss your concerns.

You can also contact the SENCO directly through the school office.

We will meet with you to discuss your concerns and try to get a better understanding of what your child's strengths and difficulties are.

Together we will decide what outcomes to seek for your child and agree on next steps.

We will make a note of what's been discussed and add this to your child's record. You will also be given a copy of this

If we decide that your child needs SEN support, we will formally notify you in writing and your child will be added to the school's SEND register.

4. How will the school know if my child needs SEN support?

All our class teachers are aware of SEN and are on the lookout for any pupils who aren't making the expected level of progress in their schoolwork or socially. This includes regular assessments.



If the teacher notices that a pupil is falling behind, they try to find out if the pupil has any gaps in their learning. If they can find a gap, they will support the pupil to fill it. This may be by slightly adapting the way things are being taught, providing some additional short term support, additional teaching or working with you to support your child with some additional practice at home. Pupils who don't have SEN usually make progress quickly once the gap in their learning has been filled.

If the pupil is still struggling to make the expected progress, the teacher will talk to the SENCO, and will contact you to discuss the possibility that your child has SEN.

The SENCO will observe the pupil in the classroom and in the playground to see what their strengths and difficulties are. They will have discussions with your child's teacher/s, to see if there have been any issues with, or changes in, their progress, attainment or behaviour. They will also compare your child's progress and development with their peers and available national data.

The SENCO will ask for your opinion and speak to your child to get their input as well. They may also, where appropriate, ask for the opinion of external experts such as a speech and language therapist, an educational psychologist, or a paediatrician.

Based on all of this information, the SENCO will decide whether your child needs SEN support. You will be told the outcome of the decision in writing.

If your child does need SEN support, their name will be added to the school's SEND register, and the SENCO will work with you to create a SEN support plan for them.

5. How will the school measure my child's progress?

We will follow the 'graduated approach' to meeting your child's SEN needs.

The graduated approach is a 4-part cycle of assess, plan, do, review.

As a part of the planning stage of the graduated approach, we will set outcomes that we want to see your child achieve.

Whenever we run an intervention with your child, we will assess them before the intervention begins. This is known as a 'baseline assessment'. We do this so we can see how much impact the intervention has on your child's progress.

We will track your child's progress towards the outcomes we set over time and improve our offer as we learn what your child responds to best.



This process will be continual. If the review shows a pupil has made progress, they may no longer need the additional provision made through SEN support. For others, the cycle will continue and the school's targets, strategies and provisions will be revisited and refined.

6. How will I be involved in decisions made about my child's education?

We will provide termly reports on your child's progress.

Your child's class/form teacher will meet you 3 times a year, to:

- > Set clear outcomes for your child's progress
- > Review progress towards those outcomes
- Discuss the support we will put in place to help your child make that progress
- Identify what we will do, what we will ask you to do, and what we will ask your child to do

The SENCO may also attend these meetings to provide extra support.

We know that you're the expert when it comes to your child's needs and aspirations. So we want to make sure you have a full understanding of how we're trying to meet your child's needs, so that you can provide insight into what you think would work best for your child.

We also want to hear from you as much as possible so that we can build a better picture of how the SEN support we are providing is impacting your child outside of school.

If your child's needs or aspirations change at any time, please let us know right away so we can keep our provision as relevant as possible.

After any discussion we will make a record of any outcomes, actions and support that have been agreed. This record will be shared with all relevant staff, and you will be given a copy.

If you have concerns that arise between these meetings, please contact your child's class teacher by asking at the school office.

7. How will my child be involved in decisions made about their education?

The level of involvement will depend on your child's age and level of competence. We recognise that no 2 children are the same, so we will decide on a case-by-case basis, with your input.

We may seek your child's views by asking them to:

- Attend meetings to discuss their progress and outcomes
- > Prepare a presentation, written statement, video, drawing, etc.
- Discuss their views with a member of staff who can act as a representative during the meeting
- Complete a survey

8. How will the school adapt its teaching for my child?

Your child's teacher is responsible and accountable for the progress and development of all the pupils in their class.

High-quality teaching is our first step in responding to your child's needs. We will make sure that your child has access to a broad and balanced curriculum in every year they are at our school.

We will adapt how we teach to suit the way the pupil works best. There is no '1 size fits all' approach to adapting the curriculum, we work on a case-by case basis to make sure the adaptations we make are meaningful to your child.

These adaptations include:

- Differentiating our curriculum to make sure all pupils are able to access it, for example, by grouping, 1-to-1 work, adapting the teaching style or content of the lesson, etc.
- Differentiating our teaching, for example, giving longer processing times, pre-teaching of key vocabulary, reading instructions aloud, etc.
- Adapting our resources and staffing



- Using recommended aids, such as laptops, coloured overlays, visual timetables, larger font, etc.
- Teaching assistants will support pupils on a 1-to-1 basis when specific programs have been put in place by external specialised teachers.
- Teaching assistants will support pupils in small groups when appropriate.

We may also provide the following interventions:

These interventions are part of our contribution to Dorset Council's local offer.

9. How will the school evaluate whether the support in place is helping my child?

We will evaluate the effectiveness of provision for your child by:

- Reviewing their progress towards their goals each term
- Monitoring by the SENCO
- > Using provision maps to measure progress
- Holding an annual review (if they have an education, health and care (EHC) plan)

10. How will the school resources be secured for my child?

It may be that your child's needs mean we need to secure:

- Extra equipment or facilities
- More teaching assistant hours
- Further training for our staff



External specialist expertise

If that's the case, we will consult with external agencies to get recommendations on what will best help your child access their learning.

The school will cover up to £6,000 of any necessary costs. If funding is needed beyond this, we will seek it from our local authority. This will usually require applying to an Educational Health and Care Plan. This plan may include recommendations about the way in which any additional funding should be used. If the school needs to recruit additional staff, they will follow the Plymouth Cast recruitment policy. Approval for all posts must be sought from the Trust before the school can begin the recruitment process.

11. How will the school make sure my child is included in activities alongside pupils who don't have SEN?

All of our extra-curricular activities and school visits are available to all our pupils, including our before and afterschool clubs.

All pupils are encouraged to go on our school trips, including our residential trips and adaption is made where appropriate.

All pupils are encouraged to take part in wider school activities.

No pupil is ever excluded from taking part in these activities because of their SEN or disability and we will make whatever reasonable adjustments are needed to make sure they can be included.

12. How does the school make sure the admissions process is fair for pupils with SEN or a disability?

The school approach to admission for prospective pupils with SEN or a disability is through the normal admission arrangements. Prospective pupils who EHC plan names the school will be admitted before any other places are allocated.

13. How does the school support pupils with disabilities?

The school has a detailed accessibility plan. This is available on the school website. For the school this does provide some specific challenges due to the design of the building. However, this is adapted to ensure that disabled pupils can fully participate in the curriculum.

14. How will the school support my child's mental health, and emotional and social development?

All Schools within the Trust are working towards becoming Trauma Informed Schools and all adults have had training to help them recognise signs that children may be having difficulty socially, emotionally or mentally. Adults are trained in ways to support children and all children have trusted adults that they can reach out to at times of difficulty. Our Pastoral Lead has completed her Trauma Informed Diploma.

We provide support for pupils to progress in their emotional and social development in the following ways:

- >We survey all pupils at least once a year to seek their views about how well they are settled in school and how well they are connected to the adults and their peers. This is called our School Bonding Questionnaire
- >We provide extra pastoral support for listening to the views of pupils with SEN by our experienced pastoral lead Mrs harding.
- We have a 'zero tolerance' approach to bullying.

15. What support will be available for my child as they transition between classes or settings, or in preparing for adulthood?

Additional transfer sessions are arranged between the local secondary schools where this is thought to be appropriate.

Between years

To help pupils with SEN be prepared for a new school year we:



- Ask both the current teacher and the next year's teacher to attend a final meeting of the year when the pupil's SEN is discussed
- >Schedule lessons with the incoming teacher towards the end of the summer term

Between schools

When your child is moving on from our school, we will ask you and your child what information you want us to share with the new setting.

Between phases

The SENCO of the secondary school will come into our school for a meeting with our SENCO. They will discuss the needs of all the children who are receiving SEN support.

Pupils will be prepared for the transition by:

- > Practising with a secondary school timetable
- Learning how to get organised independently
- Plugging any gaps in knowledge

16. What support is in place for looked-after and previously looked-after children with SEN?

The designated teacher for looked after children is Mrs Romano. She can be contacted through the school office. She will work with the SENCO to make sure that all teacher understand how a looked after pupil's circumstances and their SEN might interact, and what implications are for teaching and learning.

Children who are looked-after or previously looked-after will be supported much in the same way as any other child who has SEN. However, looked-after pupils will also have a personal education plan (PEP). We will make sure that the PEP and any SEN support plans or EHC plans are consistent and complement one another.

17. What should I do if I have a concern about my child's SEN support?

If you have concerns about the progress your child is making or the support they are receiving you should speak to the class teacher in the first instance. They may suggest that you have a meeting with the SENDCo to discuss your concerns and work together to agree how to address these. If you are still concerned you should follow the school complaints procedure. You can find a copy of that on the school website.

18. What support is available for me and my family?

19. Glossary



- >Access arrangements special arrangements to allow pupils with SEN to access assessments or exams
- ▶Annual review an annual meeting to review the provision in a pupil's EHC plan
- ▶ Area of need the 4 areas of need describe different types of needs a pupil with SEN can have. The 4 areas are communication and interaction; cognition and learning; physical and/or sensory; and social, emotional and mental health needs
- >CAMHS child and adolescent mental health services
- ▶ Differentiation When teachers adapt how they teach in response to a pupil's needs
- ➤ EHCP needs assessment the needs assessment is the first step on the way to securing an EHC plan. The local authority will do an assessment to decide whether a child needs an EHC plan
- ➤ EHC plan an education, health and care (EHC) plan is a legally-binding document that sets out a child's needs and the provision that will be put in place to meet their needs
- First-tier tribunal / SEND tribunal a court where you can appeal against the local authority's decisions about EHC needs assessments or plans and against discrimination by a school or local authority due to SEN
- ➤ Graduated approach an approach to providing SEN support in which the school provides support in successive cycles of assessing the pupil's needs, planning the provision, implementing the plan, and reviewing the impact of the action on the pupil
- Intervention a short-term, targeted approach to teaching a pupil with a specific outcome in mind
- ➤ Local offer information provided by the local authority that explains what services and support are on offer for pupils with SEN in the local area
- >Outcome target for improvement for pupils with SEN. These targets don't necessarily have to be related to academic attainment
- > Reasonable adjustments changes that the school must make to remove or reduce any disadvantages caused by a child's disability
- >SENCO the special educational needs co-ordinator
- >SEN special educational needs
- >SEND special educational needs and disabilities
- >SEND Code of Practice the statutory guidance that schools must follow to support children with SEND
- >SEN information report a report that schools must publish on their website, that explains how the school supports pupils with SEN
- SEN support special educational provision that meets the needs of pupils with SEN
- >Transition when a pupil moves between years, phases, schools or institutions or life stages
